### **Camion Transport Ltd takes over transport operations of Willi Schärer Transport AG**

**Camion Transport Ltd will take over the transport operations of Willi Schärer Transport AG in Pratteln as of 1 May 2022. This involves employees, vehicles and customer relations. With this acquisition, the family-owned company from eastern Switzerland is further expanding its partial loads and wagon loads transport division and strengthening its position as a transport and logistics service provider.**

The transport company Willi Schärer Transport AG, founded in 1961, is withdrawing completely from the «national goods transport» sector and is handing over its business activities to Camion Transport Ltd, headquartered in Wil. The two companies are united by high quality standards and a long-standing personal relationship between the owners. This led to the decision to integrate the Basel transport company into the structures of Camion Transport Ltd. Both parties see this as the most sustainable solution.

The takeover includes the customer base from the partial load and wagon load sectors, as well as the crane orders and nine vehicles, the majority of which Camion Transport Ltd will station at the Basel branch, directly next to Wolf station. The company also offers all employees continued employment. They are primarily intended for deployment in partial load and wagon load transport, i.e. in their usual field of activity.

"It is our joint ambition to continue the existing customer relationships at a high level of quality," Josef Jäger, Director of Camion Transport Ltd, emphasises, continuing: "We are also very excited about the addition of new staff. We want to integrate the new colleagues quickly into the Camion Transport family."

With this acquisition, the company is strengthening its national partial load and wagon load transport division. This benefits both existing and new customers. Willi Schärer Transport AG will continue to exist but will take on other activities in the future.

**Camion Transport Ltd (CT)** is one of the leading transport and logistics companies in Switzerland. An average of 7500 consignments and logistics orders are processed per day at the 14 locations. The family business employs 1400 people and operates a fleet of 610 vehicles.
